DEFENDANT’S OBJECTION, DEMAND, and MOTION, by right, for Paul John Hansen, as is presently called by Defendant, to be given unhindered access to the court, before the jury, for direct examination, by Defendant, and available for cross examination by Plaintiff, without the interference by any man.

Comes now, Thomas W. Hird, hereinafter known as Defendant\*, files this:

DEFENDANT’S OBJECTION, DEMAND, and MOTION, by right, for Paul John Hansen, as is presently called by Defendant, to be given unhindered access to the court, before the jury, for direct examination by Defendant, and available to cross examination by Plaintiff, without the interference by any man, for the following good and sufficient reasons should be granted, allowed, and not impaired;

**I.**

**FACTS, sworn to be true by the signed.**

- i. Defendant has sworn to be a man of right, affording all the rights enumerated in the ‘Bill of Rights’, as found in ‘The Constitution for the United States of America, acting at all times, as associated with all charges of this case, independent of land of the Plaintiff, and without any consenting contract as evidenceable between Defendant and Plaintiff.
- ii. Defendant has provided unrefuted evidence before the court of Defendant’s ‘no consent to file’ any ‘1040 U.S. Individual Tax Return’ for any year as pertinent to Plaintiff’s claims, charges. See DOC 71 as filed.
- iii. All court administrative officers, and agents, have failed to dismiss the charges, when presented written, filed, challenges from Defendant, as noticing, by use of the court record, of the lack of personal, territorial, and subject matter, jurisdiction, and the fact that the challenges were wholly unrefuted by the Plaintiff, on the record, or in open court.
- iv. That it has come to Defendant attention, based on a text dated \_\_\_\_\_, that \_\_ (Plaintiff’s Attorney) \_\_ is considering denying Defendant’s “inalienable Rights” as enumerated in the ‘Declaration of Independence’ of July 4, 1776, by blocking, by force, and meaningful time and access, to the **public** court, trial, his right to:

“In all criminal prosecutions, the accused shall enjoy the right to a speedy and **public** trial, by an impartial jury of the State and district wherein the crime shall have been committed, which district shall have been previously ascertained by law, and to be informed of the nature and cause of the accusation; to be confronted with the witnesses against him; **to have compulsory process for**

**obtaining witnesses in his favor, and to have the Assistance of Counsel for his defence.”**

Amendment VI, ‘The Constitution for the United States of America’.

URGENT / NOTICE upon United States Marshals - Defendant is in need of one, or more, United States Marshall, to attend Defendant’s trial, in Court Room 1, this day of April 6, 2021, at 8:00 until Paul John Hansen has been released as my witness, from any more examination needs. as such officers are conveniently located in the same building. This is request as a right. for the above reasons. Marshall is needed to arrest any man that violates the said enumerated rights of the Defendant, and to stop, immediately, when viewed, or personally notice any such damaging act. (⚡ this portion has been highlighted so to give absolute notice to the Marshals on duty this day.)
